In accordance with the Notice of the 23<sup>rd</sup> AGM sent to the members and the 'Advertisement' published pursuant to Rule 20 of the Companies (Management and Administration) Rules, 2014, the remote e-voting period was open from 09.00 AM IST on Friday, September 23, 2022, and was closed at 5.00 PM IST on Sunday, September 25, 2022. Members are holding shares as of Monday, September 19, 2022, the "cut-off date", were entitled to vote on the resolution stated in the Notice of the 23<sup>rd</sup> AGM of the Company.

The voting at the AGM was allowed by using an electronic voting system on the resolutions on which the voting is to be held. The said voting system was provided to all those members who attended the AGM through VC/OAVM but have not cast their votes by availing of the remote evoting facility. As per the information provided by CDSL, the name of the members who had already voted through a remote e-voting facility was blocked from voting at the AGM. After the conclusion of the voting at the AGM, the votes cast thereat were downloaded from the website evotingindia.com. Thereafter, the votes on remote e-voting were unblocked on Monday, September 26, 2022, at 01.49 PM IST, in the presence of two witnesses who were not employees of the Company and the e-voting results/list of members who have voted for and against were downloaded from the e-voting website of CDSL.

The combined results of the remote e-voting and e-voting at the AGM are given as 'Annexure-I' to this report. Based on combined results, we report that all the resolutions as per the Notice of the 23<sup>rd</sup> AGM of the Company stand passed with the requisite majority. The electronic data and all other relevant records relating to the remote e-voting and e-voting at the AGM are under my safe custody until the Chairman approves and signs the Minutes of the 23<sup>rd</sup> AGM and thereafter will be handed over to the Company Secretary of the Company for safe preservation.
