Welfare delivery must be executed with greater accountability, SC tells states

NEW DELHI: The public distribution system (PDS) remains the thin line between sustenance and deprivation for millions in India, the Supreme Court has underlined, imploring states and all other stakeholders to ensure that future exercises in public procurement, particularly those that underpin welfare delivery, must thus be executed with greater institutional coherence, foresight and accountability.

"When projects of such public importance are delayed or derailed by procedural lapses, the ultimate cost is borne not by the contracting parties but by those at the last mile of governance... It is therefore incumbent upon every stakeholder — the Government, its technical partners and

private participants — to treat such undertakings with the seriousness their human impact demands," held a bench led by Chief Justice of India Surya Kant.

The bench, also comprising justices Ujjal Bhuyan and N Kotiswar Singh, emphasised that administrative caution and technological innovation must work hand in hand to ensure that reform does not lose sight of its moral anchor — service to the poorest.

Hearing a dispute relating to procurement and deployment of ePoS (electronic point-of-sale) devices for fair price shops under the PDS, the court on Monday lamented that nearly six years had passed but the tender process was yet to be finalised.

"The tender pertains to the deployment of ePoS devices integral to the functioning of the PDS — an exercise that directly touches the lives of economically weaker citizens. To prolong uncertainty through further procedural cycles would defeat the very public purpose underlying the tender," noted the bench.

The appeal arose from a dispute concerning government tenders for supply, installation and maintenance of ePoS devices for fair price shops. The Supreme Court noted that the matter brought into sharp focus "the del-

icate balance between considerations of public interest and the constitutional prohibition on arbitrariness in State action." The Himachal Pradesh government challenged a May 30, 2024 judgment of the state's high court, which had set aside the cancellation of the Letter of Intent (LoI) issued to M/s OASYS Cybernetics Pvt Ltd and restored contractual obligations.

The judgment traced a series of tendering exercises initiated by the state from 2021 to 2022, multiple cancellations due to technical deficiencies, and eventual issuance of an LoI to the respondent company on in September 2022. The LoI was cancelled in June 2023, followed by a fresh Expression of Interest. The HC quashed the cancellation as arbitrary and directed continuation of the LoI, prompting the state's appeal.

41 MAOISTS WITH ₹1.19-CR BOUNTY ON THEIR HEADS SURRENDER: COPS

RAIPUR: Forty-one Maoists, including 32 cadres collectively carrying a bounty of ₹1.19 crore, surrendered before senior police officers in Chhattisgarh's Bijapur district on Wednesday, officials aware of the details said.

According to Bijapur superintendent of police (SP) Jitendra Kumar Yadav, the surrendered members said they were influenced by the state government's new surrender and rehabilitation policy and the Bastar police's "Poona Margham" initiative aimed at social reintegration.

Among the cadres were four members of the PLGA (People's Liberation Guerrilla Army) Battalion Number 1 and various companies of Maoists — three from area committees, 11 platoon and area committee party members, two PLGA members, four militia platoon commanders, one deputy commander, six militia platoon members, while the remaining were from frontal outfits of the outlawed CPI (Maoist).

Officials said 39 of the 41 cadres were from the south sub-zonal bureau of Maoists, and were associated with the Dandakaranya special zonal committee, Telangana state committee, and the Dhamtari-Gariaband-Nuapada divisions. Each cadre received immediate financial assistance of ₹50,000 under the rehabilitation policy, the SP said.

Yadav said the government's rehabilitation policy has encouraged Maoists to give up violence and return to the mainstream.

Excavation begins at well site in Sambhal in relation to '78 riots

MEERUT: The authorities on Wednesday began the excavation at the site of a well located in the main market near the Ekta Police outpost in the Sambhal Kotwali area, which is suspected to be connected with the 1978 riots in the district, officials familiar with the matter said.

Local residents and the family of Ramsharan Rastogi, a grocery trader, believe that 47 years ago, Rastogi was murdered and his body was disposed of in this well during the riots.

The development came after district magistrate (DM) Rajendra Pensiya and superintendent of police (SP) Krishan Kumar Bishnoi inspected the area on November 24, 2025, the first

anniversary of the 2024 Sambhal violence. The district, which has a long history of communal clashes, was rocked with violence on November 24, 2024, that claimed four lives. Dozens, including police personnel also sustained injuries.

The incident took place after a court-ordered archaeological survey of the 16th-century Shahi Jama Masjid, allegedly built over a Hindu temple, drew thousands of protesters.

One year later, during their foot patrol, the officials interacted with locals, including the deceased trader's nephew, Sushil Rastogi, whose shop stands directly opposite the well in Akbarpur Mandi.

Following appeals from the family, the DM and SP instructed city magistrate Sudhir Kumar

and Nagar Palika executive officer Manibhushan Tiwari to begin the well's excavation.

Acting on their orders, four labourers commenced digging on Wednesday in the presence of both officers.

The victim's nephew, Sushil Rastogi, 55, said that his uncle was brutally killed during the 1978 riots and his body disposed of in the well. Sushil said he was a school student at the time and was not an eyewitness.

According to a three-member judicial commission headed by justice (ret'd) Devendra Kumar Arora, Sambhal district witnessed 15 riots between 1936 and 2019, resulting in 213 deaths — 209 of them Hindus. The commission submitted the report to chief minister Yogi Adityanath in August this year.

{ 'C'GARH LIQUOR SCAM } 7TH CHARGE SHEET

EOW names former excise secy

RAIPUR: The Economic Offences Wing (EOW) on Wednesday filed the seventh charge sheet in the ongoing investigation into the Chhattisgarh liquor scam before the Special Court (Prevention of Corruption Act) in Raipur. The charge sheet names six accused, including former excise commissioner and secretary Niranjana Das.

With this, charge sheets have now been filed against 50

accused so far, officials said.

According to EOW, during his nearly three-year tenure in the excise department, Das allegedly deliberately changed the excise policy, manipulated departmental tenders and introduced irregularities in administration to extend benefits to a syndicate operating inside the department. This syndicate was allegedly patronised by Anil Tuteja and Anwar Dhebar.

The faulty licensing policy resulted in a revenue loss of at least ₹530 crore to the state

exchequer.

Das allegedly received a monthly share of no less than ₹50 lakh, and earned at least ₹16 crore in illegal proceeds, which were invested in immovable properties under his and his family members' names, the probe revealed.

The charge sheet also mentions the role of Om Sai Beverages Pvt Ltd directors Atul Singh and Mukesh Manchanda, who allegedly acted as intermediaries between the syndicate and liquor manufacturing firms.
