CM announces ₹700 crore for slum development

Delhi Chief Minister on Wednesday said the Delhi Government is committed to the welfare of poor families living in slum clusters, which is why a dedicated budget of ₹700 crore has been allocated for their development.

Through this fund, Ayushman Arogya Mandirs, Atal Canteens, Basti Vikas Kendras, road and drainage improvements, and other essential facilities are being developed in slum areas, she said after attending the three-day Swabhiman Sabha held at 8-Block in Wazirpur Industrial Area.

Addressing the gathering,

the Chief Minister highlighted the long-standing issues and neglect faced by poor families living in Delhi's slum settlements for decades. She said that previous Governments treated these settlements merely as vote banks and failed to provide basic amenities such as toilets, parks, roads, drainage systems, and permanent housing.

She alleged that their approach was to "keep the poor poor and keep them frightened". Previous governments spent crores of rupees to build 50,000 flats but never allowed the handovers of the poor as their own, leaving them to deteriorate and crumble.

The Chief Minister said



Prime Minister Narendra Modi underlined the hardships of the poor as his own, which is why he launched nationwide welfare initiatives such as the construction of toilets, the Ujjwala gas connection scheme, permanent housing, free ration, and several other schemes,

benefiting millions of poor families today.

She made it clear that every slum resident in Delhi now has the right to a permanent home. She added that previous Governments allowed ready-built government flats to lie unused for years, causing them to decay, whereas her government is ensuring that every poor family receives a dignified permanent home.

The Chief Minister further announced that the process of issuing new ration cards which had been halted for nearly 15 years will be restarted, cancelling cards of ineligible beneficiaries and issuing new ones to genuine needy families.

Similarly, discontinued pension schemes are also being revived. She said that after her government came into office, all suspended processes related to ration cards, pensions, and other welfare schemes have been reactivated. She emphasised that development can only be sustained when public representatives, Members of Parliament, MLAs, and councillors work in the same direction.

On this occasion, the Chief Minister appealed to the public to strengthen the momentum of development by voting in support of BJP candidate Veena Aseja from Ward 65, Ashok Vihar in the MCD polls on November 30.

2 arrested under Operation Kawach 11

Delhi Police has carried out a citywide crackdown under 'Operation Kawach 11.0', arresting over 2,000 persons in several cases, ahead of the MCD bypolls.

Police said that the 24-hour drive launched at 6 pm on Monday aimed to deter drug trafficking networks and disrupt their activities ahead of the upcoming MCD bypolls in 12 wards on November 30. Under the operation, 508 people were arrested, including 1500 raddis across all 15 police districts, targeting hotspots, repeat offenders, and vulnerable pockets identified through local intelligence.

The police said that 80 people were arrested in connection with 76 NDPS cases, 273 arrested/apprehended in 273 excise cases, 100 arrested in 99 Arms Act cases, 213 arrested in 117 Gambling cases, 16 auto-lifters arrested, 24 proclaimed offenders were arrested and 1,500 arrested for drinking in public.

A senior police officer said under the preventive arrests and actions, 542 people were arrested under Sections 126 and 170 of the BNSS, 2,516 taken into preventive custody, 23,387 detained under Section 65 of the Delhi Police Act, 3,837 bad charac-

ters were checked, and 4,857 prosecuted under COTPA.

"Multiple teams of the Crime Branch and Special Cell, along with the police officers of all the districts in the capital, were alert during the operation, and this was among the biggest single day coordinated enforcement actions carried out by the Delhi Police in recent years," the officer said.

He further said that during the operation, over 282 grams of heroin, 19.235 kg of weed, 2,147 kg opium, 2,034 kg drugs, 704 medical capsules and 85.102 lakh in cash were recovered during the operation.

"A major seizure came from Narela, where Crime Branch arrested Lekh Raj alias Vicky with 4,704 Tramadol capsules and 200 gm opium after a targeted operation based on a tip-off," the officer said. Two Nepal nationals were held with 2,034 kg of heroin from a hotel in Sarita Vihar, he said, adding that in east Delhi, the police seized 1.947 kg opium and 109.5 gm heroin from two men interlocked near Chabutra.

The officer said several bottles of liquor were also seized. Sharing details about weapons, the officer said that one pistol, 13 country-made pistols, 6 live cartridges, 87 knives and multiple vehicles were also recovered.

Official song for MCD bypolls launched

Joint Secretary Adeshwar Kant stated that the theme song will be disseminated widely across digital platforms, social media, outdoor screens, and community outreach channels to maximise public awareness in 12 wards.

Sood warns MCD officials over cleanliness lapses

Delhi Urban Development Minister Ashish Sood on Wednesday warned officials regarding cleanliness and waste management lapses and said the Delhi Government is committed to strengthening cleanliness and civic amenities across every part of Delhi.

He made this assertion after inaugurating the cleaning work of the approximately 6.85-kilometre-long trunk sewer line running from Jail Road to the Keshpur Sewer Treatment Plant. An expenditure of ₹13 crore will be incurred on the cleaning of this sewer line.

This main line, with a diameter of about 15 metres, had not been cleaned for many years and had nearly 55 per cent deposit. As a result, areas such as Virender Nagar, Shiv Nagar, Hari Nagar, and several parts of Janakpuri were facing sewer overflow and drainage problems. In addition, Sood also inspected cleanliness and waste management in several blocks of Ward 104 in Janakpuri.

Sood informed that this trunk sewer line is being cleaned after many years, whereas as per norms, desludging and cleaning must be carried out every five years.

According to available records, only a small portion of this line was cleaned in 2013. After that, the work received no attention.

He also said that previous Governments did not show seriousness towards the cleaning of this trunk sewer line, due to which residents of the affected areas faced multiple issues for years.

The Urban Development Minister informed that the work will be carried out by temporarily diverting sewer flow between two manholes through a bypass line. All accumulated silt inside the pipeline will be removed using advanced machinery.

He further stated that the tendering process for this work has been completed. Sood added that once cleaned, the trunk sewer line will provide major relief from sewer overflow to thousands of residents of Virender Nagar, Shiv Nagar, the areas near Jail Road, some affected parts of Hari Nagar constituency, and A-Block, B-Block and several other areas of Janakpuri.

The Minister also informed that a new 200-meter sewer line is being laid under the District Centre metro station, which will further enhance the drainage capacity of the Janakpuri area.

Sood said that once the trunk line is cleaned, the sewer



problem will improve significantly within the next six months. Thereafter, wherever local sewer lines are found broken or damaged, new lines will be laid immediately.

After this, Sood inspected many blocks of Ward 104 in Janakpuri and reviewed the cleanliness and waste management situation. During the inspection, the Minister also discussed various issues with officials and representatives of the waste management agency.

Residents of C-4/A Block informed the minister that waste often flies scattered around the local garbage collection point. There is no proper waste handling system at this site. They also highlighted issues like broken footpaths at several locations and uncovered drains. Sood instructed MCD

and PWD officials on the spot to prepare a comprehensive plan for relocating garbage collection points of all wards in Janakpuri from residential areas to commercial locations.

Residents of C-4/E Block thanked the Minister for getting the overhead electricity cables of their block shifted underground. Shri Sood assured all residents of Janakpuri that the work of undergrounding overhead electricity lines throughout the constituency will be taken up on priority.

In response to requests from residents of Ward 104, the Minister also issued strict directions to officials regarding pruning of trees, proper maintenance of parks, upkeep and cleanliness of public toilets, road construction, and other civic works.

Pankaj Kumar conducts inspection in Pandav Nagar

Delhi Health and Transport Minister Dr Pankaj Kumar Singh on Wednesday conducted a field inspection in Pandav Nagar of the Laxmi Nagar Assembly Constituency to assess sanitation and cleanliness measures on the ground.

During the visit, he interacted with local residents to understand their concerns and take first-hand feedback on civic services. The Health Minister emphasised that under the ongoing drive to enhance sanitation, pollution control, and civic facilities, a detailed review was

carried out in Ward-200.

Dr Singh took a serious note of heavy waste build-up inside a 15-foot-deep drain at Budh Marg, Fazalpur in Mandawali, and instructed officials from the Delhi Jal Board (DJB) and Municipal Corporation of Delhi (MCD) to take immediate action. He directed that the measures be implemented within one week, instructing that any delay or negligence will be viewed strictly.

Reviewing the sanitation initiatives being carried out under the cleanliness drive, the Minister evaluated dust control measures and air pollution mitigation actions across the locality.
