Pursuant to regulation 30 read with sub-para 20 of Para A of Part A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that HCL Infosystems Limited ("the Company") has received an Order on 26 December 2025 bearing reference no. 27/2025-26 (GST)-AC-Section 74 dated 24 December 2025 passed by the Assistant Commissioner, Central Goods & Services Tax, Chennai under the provisions of the Central Goods and Services Tax Act, 2017 ("CGST Act, 2017").

The said order pertains to the financial year 2018–19 and has been passed in relation to an allegation of generation of multiple E-Waybills using the same invoices resulting into short payment of tax. Vide the aforesaid Order-in-Original, a tax demand of ₹ 0.32 crores has been confirmed against the Company, along with interest levied under Section 50 of the CGST Act, 2017 and equivalent penalty of ₹ 0.32 Crores imposed under Section 74 of the CGST Act, 2017.

The Company is of the view that the demand is not sustainable, as it has duly discharged its applicable tax liabilities in the relevant periods and has good grounds on merits as well as on legal and procedural aspects.

The Company is currently examining its options for appropriate legal remedies in accordance with the law. Also, the Company does not expect any material adverse impact on its financial position or operations at this stage.
