Pursuant to Regulation 30 read with Part A of Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”), this is to inform you that the Company has received Order under the provisions of Section 74 of the CGST Act, 2017 and UPGST Act, 2017 read with Section 20 of the IGST Act, 2017 and Section 50 of the CGST Act, 2017 along with Summary of order including demand details for the Financial year 2018-19 to Financial year 2022-23 imposing a penalty of Rs. 15,35,080/- and Rs. 28,972/- in relation to alleged excess Input Tax Credit claimed by the Company and short payment of tax liability, respectively.

The Company is not satisfied with the said order and intends to file appeal before the concerned authority. The Company confirms that the said intimation has no material impact on its financial operations or any other activities of the Company.
