BEIJING CAN RENEW REQUEST AT NEXT DISPUTE SETTLEMENT BODY MEET

India blocks China move to set up WTO panel on EV incentives

INDIA HAS BLOCKED a request from China for the establishment of a dispute panel on India's incentive programme for the electric vehicle ecosystem at the World Trade Organization (WTO). China can renew its request at the next meeting of the Dispute Settlement Body, officials said.

On October 15 last year, China had sought consultation on its Production Linked Incentive (PLI) schemes for Advanced Chemistry Cell (ACC) Battery Storage, and Automobile and Auto Component Industry. The Scheme to Promote Manufacturing of Electric Passenger Cars in India was also included in the challenge. In its commun-



nication, China had maintained that the scheme's incentivising use of domestic over imported goods or otherwise discriminated against goods of

Chinese origin. The EV Passenger Cars Scheme was announced in March 2024 to attract global EV manufacturing investment

in India. It allows imports of a limited number of cars at reduced customs duties of 15% provided applicants establish manufacturing facilities in India within three years of approval with a minimum investment of ₹4,150 crore.

The PLI ACC Scheme targets the establishment of a cumulative domestic manufacturing capacity of 50 gigawatt-hours for ACC batteries, with an additional 5 GWh reserved for niche, higher performance ACC

technologies. Trade diplomats of both sides held two rounds of consultation — on 25th November 2025 and 6th January 2026. As consultations failed to resolve the issue, China sought for the establishment of the panel. If consultations fail, the complaining country can request the establishment of a panel to probe the complaint. After hearing all the sides the panel issues its recommendations that are put before the Dispute Settlement Body (DSB).

Bank strike over five-day week demand hits operations

BRANCH BANKING OPERATIONS like cheque clearance, deposit and withdrawal of cash across many places in the country were impacted on Tuesday as the United Forum of Bank Unions (UFBU) observed a nationwide strike demanding the immediate implementation of a five-day work week.

The strike by the UFBU, an umbrella body of nine unions representing officers and employees, materialised after a conciliation meeting with the Chief Labour Commissioner on January 23 failed to yield a positive outcome. Nearly 800,000 employees of various unions of public sector banks participated in the strike call given by UFBU.

According to estimates, cheques worth ₹4 lakh crore were held up for clearance, cash transactions were impacted and bill trading, bill discounting and trading were affecting and treasury operations at the public sector banks were also shut at many places. All India Bank Employees Association (AIBEA), a constituent of UFBU, general secretary C H Venkatachalam told PTI.

In December 2023, after discussions it was agreed that the daily working hours from Monday to Friday will be increased by 40 minutes and the remaining Saturdays will be declared as holidays. All India Bank Officers' Confederation (AIBOC) General Secretary Rupam Roy said.

This has been duly recommended to the government but unfortunately it is pending approval for the past two years, he said.

Reports coming from Madhya Pradesh and Jharkhand indicate that banking services were impacted and many ATMs were running dry.

Most branches of public sector banks across the country were either completely closed or partially closed as both employees and officers were observing Tuesday's strike.

Services such as cash deposits, withdrawals, cheque clearances, and administrative work are hit at branches of all public sector banks (PSBs) and some old generation private sector banks.

However, operations at major private sector lenders like HDFC Bank, ICICI Bank, and Axis Bank are expected to remain largely unaffected as their employees are not part of the striking unions.

Digital banking services, including UPI and internet banking, were working fine as there were no reports of outage.

"We advise that while the bank has made necessary arrangements to ensure normal functioning in its branches and offices on the day of the strike, it is likely that work in the bank may be impacted by the strike," SBI said in a regulatory filing on Friday.

According to another UFBU constituent National Confederation of Bank Employees (NCBE) General Secretary L Chandrasekhar, the resounding success of today's strike sends an unmistakable message that 5-day banking is not a luxury but a necessity, essential for work-life balance, employee well-being and sustainable banking services.
