- Components:
 - CRGO Processing Capacity increased from 16,200 MTPA to 28,000 MTPA
 - Intend to venture into other transformer components, except for oil & copper winding wires
 - Recently started manufacturing & supply of Vacuum Circuit Breakers (VCBs)
- Transformer
 - Capacity Expansion is in progress and expected to be completed by Q3 FY27
 - New plant equipped to manufacture 132 kV / 100 MVA transformers, an upgrade from 33kV / 10 MVA under the current facility
 - Type test of IDT transformer under process
- EPC & Others
 - Execution of projects at Pratapgarh, Alwar, Bambori & Dalot sites progressing well
 - Current EPC orders in hand is ₹140crs
