1) Based on the recommendation of Nomination and Remuneration Committee, approved the proposal to place before the shareholders of the Company, the appointment of Ms. Amrita Gangotra (DIN: 08333492) as an Independent Director of the Company, with effect from May 06, 2025 for a period of three consecutive years. Ms. Amrita Gangotra has no relationship with any member of the Board of Directors and meets all the criteria for being appointed as an Independent Director under applicable laws, including circulars issued by the stock exchanges. A brief profile of Ms. Gangotra is enclosed as Annexure I.

- 2) Approved the Postal Ballot Notice to seek shareholders' approval for the appointment of Ms. Amrita Gangotra as an Independent Director for a term of three consecutive years, with effect from May 06, 2025. The Postal Ballot Notice shall be filed with the exchanges separately and shall be sent to the shareholders in due course.
- 3) Based on the recommendation of Nomination and Remuneration Committee, approved the appointment of Mr. Vaibhav Srivastava as Country HR Head (Senior Management Personnel) with effect from May 01, 2025.

The relevant details with respect to the above appointment of Senior Managerial Personnel, as prescribed under Clause 7 of Para A of Part A of Schedule III of the SEBI Listing Regulations read with the SEBI circular SEBI/HO/CFD/CFD-PoD1/P/CIR/2023/123 dated 13th July, 2023 is enclosed as Annexure II.

The Meeting of the Board of Directors of the Company commenced at 06.45 p.m. and concluded at 07.10 p.m.
