

Excise Duty is shown as expenses separately for those periods.
- 5 The figures for the current quarter and the quarter ended March 31, 2017 are the balancing figures between audited figures of the full financial year ended March 31, 2018 and March 31, 2017 respectively and published year to date figure upto third quarter ended December 31, 2017 and December 31, 2016 respectively.
- 6 Figures for the comparative periods have been regrouped wherever necessary in conformity with present classification.
