# NGT slaps ₹25,000 fine on Delhi govt for not filing report

he National Green Tribunal (NGT) has slapped Rs 25,000 as costs on the Delhi government for failure to file a report on the action taken to prevent blockage of drains in the city.

A bench headed by Acting NGT Chairperson Justice Jawad Rahim directed the AAP government to file its response within 10 days and deposit the fine within a week.

The order came on a plea filed by city-based Rajokari Youth Welfare Society seeking a direction to the Delhi government to take action to remove blockage of drains in the national capital.

The tribunal said despite the petitioner highlighting the immediate need for appropriate act to prevent ob-

struction in drains the respondent Government of NCT, Delhi, and the district magistrate concerned failed to respond.

"We have forfeited the right to file objection," the bench said.

"Considering the fact that Government of NCT, Delhi has to explain lot about the state of affairs which compelled initiation of proceedings in this case, we permit filing of the statement of

Delhi government within a period of 10 days subject to payment of Rs. 25,000 as costs.

The costs shall be paid within one week and only then they shall be permitted to file the reply in the registry," it said.

The tribunal had earlier directed the city government and the civic bodies to restore expeditiously all water bodies and ensure that these remain clean and not become waste-dumping yards.

The green panel had said that water bodies surrounding colonies should be maintained and kept clean so that they become a source of natural beauty.

It had also approved a proposal put forward by the Delhi Jal Board to revive Rajokari water body in south-west Delhi and develop it in an aesthetic manner.

### Ateli- Phulera section freight corridor to be open from August 15

New Delhi The Ateli- Phulera section freight corridor that falls in Haryana (Mahendragarh district) and Rajasthan (Jaipur district), is to be open from August 15, 2018.

Chairman, Railway Board, Ashwani Lohani, has already inspected the aforesaid Ateli-Phulera section of western dedicated freight corridor and announced that the said dedicated freight corridor would be started on 15th August 2018.

Lohani inspected structures and discussed critical issues. The distance between two stations is 190 Kms and it falls in Haryana (Mahendragarh district) and Rajasthan (Jaipur district). This section contains 10 number of viaducts and major bridges, 127 number of mi $nor\,bridges, one\,rail\,fly\,over$ and 118 road under bridges. There are 6 DFC stations in this section and two junctions, i.e. Ateli and Phulera.

The chairman of the Railway Board also took keen interest in some of the latest construction methodologies, like mechanised boring / auguring of mast foundations, erection of electrical poles through mast grabber , which are being tried for the first time to expedite the progress of project. DFCCIL will run freight train at the maximum speed of 100 km/per hour as against the current maximum speed of 75 kms per hour on Indian Railway tracks whereas the average speed of freight trains will also be increased from existing speed of 26 km/ph on Indian Railways lines to 70 km/ph on Dedicated Freight Corridors (DFC)

DFCCIL, a special purpose vehicle (SPV) is engaged in planning, construction, operation and maintenance of the Dedicated Freight Corridors and in the first phase, the two corridors, namely Eastern Corridor from Ludhiana to Dankuni (1856 Kms) and the Western Corridor from Dadri to Jawahar Lal Nehru Port (JNPT) (1504 Kms) are being constructed for exclusively movement of Goods Trains.

The Eastern Dedicated Freight Corridor from Ludhiana to Dankuni near Kolkata is traversing states of Punjab, Haryana, Uttar Pradesh, Bihar, Jharkhand and West Bengal. The Western Dedicated Freight corridor from Dadri (Uttar Pradesh) to Jawaharlal Nehru Port Trust (Mumbai) is passing through Uttar Pradesh, Haryana, Rajasthan, Gujarat and Maha-

rashtra. The western corridors is being funded by Japan International Corporation Agency (JICA), while the Eastern Corridor from Mughalsarai to Ludhiana is being funded by the World

The recoveries also included income tax assessment orders of various companies and Suspicious Transaction Reports (STRs) of nearly 140 companies generated by the Financial Intelligence Unit (FIU) after a joint CBI-ED searches on Rai and his associates.

The probe agencies along with the Income Tax Department conducted fresh searches in Gurgaon, Kolkata and Mumbai over the week against a number of people including few tax department officials on the basis of these disclosures.

The agencies have seized, during the first round of searches at the premises of Rai and his associates, a confidential communication between the Indian High Commission in Singapore and former ED Director Rajan Katoch in connection with a case related to industrialist Naveen Jindal, the officials

A letter written by Jindal to Katoch in 2015 has also been recovered from the cache apart from a secret inquiry report of foreign assets and a note shared by a Special Director of the ED in the backdrop of the Singaporean FIU taking umbrage on the leakage of its shared information in the Indian

The officials told PTI that documents pertaining to four IT assessment orders against Mumbai-based companies have been recovered from the premises of Sanjay Snehi, an associate of Rai who is being probed in the case.

Among other seizures made from the premises of Snehi are CDRs of a senior Enforcement Directorate (ED) officer investigating the Supreme Court monitored Aircel-Maxis case, that of an IAS officer who served as a Joint Secretary in the Ministry of Corporate Affairs, of a journalist owning an Hindi news portal and those of Rai's wife Rachna, among

All of these are suspected to have been sourced by Rai some years back, a senior official said. The searches had more surprise for the officials when the sleuths recovered a confidential note of 2010 of an ex-ED Additional Direc-

tor, now a senior officer in the Delhi Police, to the then CBI Director "complaining" about the activities of Rai.

"The highly classified letter is recovered from a man who himself is the subject of discussion and question in the note. A full enquiry is on to find as to how this document was leaked to Rai," the official said.

Documents related to a disproportionate assets case charge sheet filed by the CBI against former Noida Chief Engineer Yadav Singh have also been seized by the probe agencies after raids on Rai and his associates Snehi, Rahul Sharma and others early this month.

Among the other sensitive documents in raids against Rai is a 2015 ED complaint filed against meat exporter Moin Qureshi and

Qureshi is being probed by the ED, the IT department and the CBI for alleged tax evasion and money laundering after his purported dubious links with former CBI Director A P Singh came to the fore.

A total of 140 STRs, generated by the Financial Intelligence Unit to check dubious, black money and terror-financing linked transactions in the country's economic channels, have also been seized from a pen drive found at Rai's premises as part of these recoveries.

The highly sensitive and confidential STRs, of the period between 2015-16, are largely connected to those firms which are being probed by various agencies for tradebased money laundering, black money generation and export/import frauds, including one related to the son of a former chief minister.

The agencies are now probing at least 14 accounts in the name of Rai, his family and company in various banks in Delhi, eight luxury cars like Audi, Mercedes, Honda and Innova and three firms linked to him --M/s Upendra Rai and Associates, Ms Clear Water So-

lution and M/s Brandbird

Marketing Services. The agencies have found that Rai owns two flats in the upscale GK-I locality in the national capital, one flat each at the Hailey Road in Delhi, Noida, Ghaziabad, Nashik (Maharashtra), and two in Lucknow in the his and his family's name. The ED may attach them under the

Three id cards issued by the Bureau of Civil Aviation Security (BCAS) in the name of Rai have also been recovered and are being investigated, even as the journalist is being probed for allegedly using a fake Aerodrome Entry Pass (AEP) to enter sensitive areas of "all" the airports in the country.

Some email questionnaires sent by Rai and his associates to business groups and other individuals is also under the scanner, the official said.

A number of mobile phones and hard disks of Rai and his associates have been sent for forensic examination by the probe agencies which is expected to reveal more information about Rai's links and contacts with government officials and politicians, he said.

The ED and the CBI are probing Rai under criminal sections of the Prevention of Money Laundering Act (PMLA) and the Prevention of Corruption Act respectively.

He is at present in judicial custody after the CBI arrested him on charges of alleged extortion and manipulation of an Income Tax Department case against a Mumbaibound businessman.

Department Telecommunications (DoT) has extended the last date for submission of comments on the recently published draft National Digital Communications Policy (NDCP), 2018 upto June 1, 2018.

Several stakeholders had requested DoT to provide more time for giving inputs on the draft Policy. Earlier the deadline was set as 25th May 2018.

Now the public and stakeholders may now give their comments till 1st June 2018 through the MyGov portal, where the draft Policy has been hosted for public comments. It can be accessed at https://innovate.myg draft-ndcp-2018/.

Several stakeholders had requested DoT to provide more time for giving inputs on the draft Policy. Earlier the deadline was set as 25th May 2018.

The DoT had released the draft NDCP on 1st May 2018 for public comments. The key objectives of the policy include broadband for all, creating 4 million additional jobs in the digital communications sector, enhancing the contribution of the digital communications sector to 8% of India's GDP from around 6% in 2017, propelling India to the top 50 nations in the ICT Development Index of ITU from 134 in 2017, enhancing India's contribution to global value chains, and ensuring digital sovereignty of the country.

## My grandmothers didn't tell me stories: Ruskin Bond

Many children had their granny as their first storyteller but author Ruskin Bond says neither of his grandmothers told him any tale while he was a kid.

As a boy, the author was very fond of reading and wanted to emulate his favourite authors and be one of them himself. He read everything he could lay his hands on - from Charles Dickens, PG Wodehouse, Somerset Maugham to Graham Greene.

"I read everything from detective stories to the classics. It all made a difference. The books, the authors you read in the formative years are the ones that have the most impact," says Bond, who turned 84 on

The prolific writer says the

love of language and literature has kept him going. And he is also inspired by nature and the streams, hills and trees.

"Many people had their grandmothers to tell them stories but nobody told me any. I started reading early and thus I read my own stories," he says.

"One of my grandmothers

was a very silent woman, the other one used to scold me a lot. So I don't recall them telling me any story," Bond told PTI in an interview.

Asked if he would have taken any other profession if not writing, he says, "Even before I finished school, I wanted to be a writer. So any other ambition at

that time would have centred around being a football player or a tap dancer that I wouldn't be doing anyway. So I think I probably made the right choice."

On whether he fears that he might run out of ideas, the writer says, "The older you get the more you have to look back upon. Life stretches behind you. So you don't really run out of people, you might run out of

places in a way. So you have more to write about as you grow

Bond was born in Kasauli, Himachal Pradesh, and grew up in Jamnagar, Dehradun, New Delhi and Shimla. As a young man, he spent four years in the Channel Islands and London. He returned to India in 1955. He now lives in Landour, Mussoorie, with his adopted family.

At the age of eight, Bond escaped his jail-like boarding school in the hills and went on to live with his father in Delhi. His time in the capital is filled with books, visits to the cinema, music, and walks and conversations with his father - a dream life for a curious and wildly imaginative boy, which turns tragic all too
