GIST OF PROCEEDINGS OF THE 30TH AGM OF SONAL ADHESIVES LIMITED

1. Date, time and Venue of the Meeting:

The 30th Annual General Meeting of the Company was held on Monday, the 27th September, 2021 and the meeting commenced at 4:00 p.m. through Video Conferencing. The meeting was concluded at 4:08 p.m.

2. Brief details of items deliberated at the Meeting and result thereof:

- Mr. Nitin Rane, chaired the proceedings of the Meeting.
- The requisite quorum being present, the Chairman called the Meeting to order.
- The Chairman then delivered his speech.
- The Chairman informed that remote e-voting commenced at 9:00a.m. on 24th September, 2021 and ended at 5:00 p.m. on 26th September, 2021. He also informed the availability of e-voting facility during the meeting for the members, who did not use the remote e-voting facility, to cast their vote of the business items of the Notice of Meeting.
- The following items of Ordinary and Special Business as set out in the Notice calling the Meeting were put for shareholders' approval:
 - (a) To receive, consider and adopt the Audited Balance Sheet as at March 31, 2021 and the Statement of Profit / Loss Account for the year ended on that date and the reports of the Auditors and Directors thereon
 - (b) To appoint a Director in place of Mrs. Mridu Sandeep Arora (DIN: 07260461), who retires by rotation and being eligible, offers herself for re-appointment
 - (c) To Sale of Company's land (undertaking.) situated at Village Dheku, Takai Adoshi Road, Taluka Khalapur, Dist Raigad, Khopoli - 410 203
- The Chairman informed the members that Mr. Prashant Diwan, Practicing Company Secretary was appointed as the scrutinizer for the purpose of scrutinizing the remote e-voting process and e-voting facility provided during the Annual General Meeting.
