**Note:** Please note that pursuant to BSE circular no. LIST/COMP/01/2019-20 dated April 2, 2019 and NSE Circular no. Ref No: NSE/CML/2019/11 dated April 02, 2019 titled "Clarification regarding trading restriction period", the trading window shall close from the end of every quarter i.e. March 31, June 30, September 30 and December 31 and shall open only after 48 hours of declaration of financial results for every quarter approved at the concerned Board Meeting. The date of Board Meeting for considering the financial results shall be intimated as and when decided.
