Dear Sir / Madam,

This is in reference to the application submitted by Sumeet Industries Limited ("Company") for seeking Reclassification of Promoter Shareholders under the provisions of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, (LODR) wherein Regulation 31A(8)(c) states that:

"The following events shall deem to be material events and shall be disclosed by the listed entity to the stock exchanges as soon as reasonably possible and not later than twenty-four hours from the occurrence of the event:

(c) submission of application for re-classification of status as promoter/public by the listed entity to the stock exchanges."

It has been observed that the Company submitted the application with the Exchange on November 26, 2025. However, disclosure regarding the same has been submitted on January 20, 2026.

Hence it is observed that the timelines stipulated under Regulation 31A(8)(c) have not been adhered to.
