GHCL announces Q3 FY26 Results

Reports 5% QoQ revenue growth; PAT sees marginal 0.8% QoQ decline

New Delhi, 29th January 2026: GHCL Limited, India's leading Chemical Company, today announced its financial results for Q3 FY26.

Commenting on the financial performance, Mr. R S Jalan, Managing Director, GHCL Limited said, "Our performance in Q3 FY26 remains consistent with the previous quarter, reflecting a stabilizing yet challenging operational landscape. The domestic soda ash market continues to navigate significant headwinds, primarily driven by a persistent influx of cheap imports and aggressive global pricing strategies. Despite the continued flow of soda ash exports into the Indian market, GHCL has maintained its industry-leading margins.

A significant highlight of this quarter was the successful conclusion of our ₹300 crore **share buyback programme**. Our **diversification projects** are reaching a critical milestone. While heavy monsoon in Gujarat caused minor delays, our Bromine and Vacuum Salt projects are now in the final stages of execution and are on track for commissioning by the end of Q4 FY26. Looking ahead, our long-term outlook remains firmly positive."

Financial Performance (Standalone)

Q3 FY26 VS Q3 FY25

- **Net Revenue** declined by 4.6% to Rs. 773 crores as compared to Rs. 807 crores in the corresponding quarter of the previous year
- **EBIDTA** declined by 32.1% to Rs. 175 crores as compared to Rs. 259 crores in Q3 FY25
- **Net Profit** declined by 36.6% to Rs. 107 crores as compared to Rs. 168 crores in Q3 FY25

Q3 FY26 VS Q2 FY26

- **Net Revenue** increased by 4.6% to Rs. 773 crores as compared to Rs. 739 crores in previous quarter of this year
- **EBIDTA** increased by 0.3% to Rs 175.49 crores as compared to 174.93 crores
- **Net Profit** declined by 0.6% to Rs. 106.70 crores as compared to 107.36 crores
