Delays persist: Rejected beneficiaries await ration cards

RATION card applicants who were denied approval are still awaiting the issuance of enduring ration cards, encompassing a substantial proportion approximately 40 to 50 percent of migrants and unorganised laborers are among the 1,06,818 rejected cardholders. Despite the Supreme Court's directive over a month ago, mandating the allocation of ration cards to all migrants and unorganised workers under the National Food Security Act (NFSA) through the e-Shram portal, the registration procedure is yet to commence in the State.

In an endeavor to draw the attention of the Civil Supply Department, social activists have fervently implored the Telangana government to expedite the issuance of ration cards for migrants and unorganised workers. The absence of these essential

cards has rendered them unable to access the associated benefits, thereby necessitating urgent action from the authorities.

SQ Masood, a prominent social activist, expressed deep concern over the persistent delay in initiating the registration process for ration cards, as mandated by the Supreme Court on April 20. "Despite the court's direc-

tion to provide ration cards to all migrants and unorganised workers through the e-Shram portal under the National Food Security Act (NFSA), the Telangana government is yet to commence the registration procedure." Since the formation of Telangana, the government has failed to issue permanent ration cards to beneficiaries. In 2016, a staggering num-

ber of 1,06,818 cards were arbitrarily rejected without any on-site inspections, and a substantial portion of these rejections, approximately 40 to 50 percent, pertained to migrants and unorganised workers. Regrettably, the registration process for new cardholders has remained stagnant ever since, he added.

These unorganised work-

ers are facing hardship to avail various benefits, the State government should also universalise access to the Public Distribution System (PDS) for all migrant/unorganised sector workers and provide access to ration cards without complex inclusion and exclusion criteria," said Maria Arifuddin, another social activist.

R Anil, an unorganised worker and rightful beneficiary, expressed his frustration at the rejection of his ration card, even after the Supreme Court's order to provide Ration Cards under the National Food Security Act (NFSA) on the e-Shram portal. Despite the court's directive, the progress towards issuing the cards has not yet commenced. He conveyed his exasperation at repeatedly requesting the concerned officials to issue him a permanent ration card, only to face inaction and no resolution to his situation.

DRDO holds interactions with industries and start ups

A day-long industry interaction and brainstorming session was held at the Research Centre Imarat (RCI), Hyderabad, organised by the Defence Research and Development Organisation (DRDO). The aim was to bring together all defence industries, including MSMEs and start-ups, on a single platform to address their concerns.

Dr Samir V Kamat, Secretary of the Department of Defence R&D and Chairman of DRDO, chaired the session and assured the industry of DRDO's full support. He emphasised DRDO's role as a mentor in enhancing their capabilities to transform India into a net defence exporter. He also stressed the importance of regular initiatives like this to boost the Indian defence manufacturing sector and achieve complete self-reliance.

Arun Chaudhary, Director of the Directorate of Industry Interface & Technol-

ogy Management (DIITM), provided insights into the selection process of industries as development cum production partners and explained the highlights of the Technology Development Fund (TDF) scheme. He also shared details of DRDO's policies and procedures regarding the utilisation of its infrastructure testing facility and DRDO patents by Indian industries.

During the session, an overview of the System for Advanced Manufacturing Assessment and Ranking (SAMAR) was presented, along with the IT-enabled online model for digitized as-

essment featuring geo-tagging and time-stamping. This interactive session served as a platform for open brainstorming, allowing industries to express their challenges, expectations, and the support required in the current scenario. The discussions aimed to create a redefined framework that promotes ease of doing business and facilitates the industry, aligning with the vision of DRDO.

According to a senior officer from DRDO, this session marked a unique beginning for Aatmichintan and Manthan, providing valuable insights and opportunities for the industry.

TPHDA representatives meet Health Minister

THE Telangana Public Health Doctors Association (TPHDA) representatives met Health Minister T Harish Rao on Sunday, emphasising the urgency of resolving their longstanding issues. TPHDA State President Kathi Janardhan brought several concerns pertaining to doctors and medical staff to the attention of the Health Minister.

Among the primary issues highlighted by the doctors were the allocation of newly created posts of District Medical and Health Officer (DMHO) based on seniority, granting promotions to Civil Surgeons. Further, they urged for the sanctioning of positions for all doctors working in public health and family welfare, including CAS cadre, DCS, and CS cadres. It was also stressed that career advancement opportunities and promotions should be provided to public health doctors, along



with the implementation of public health management cadres and mobility support for doctors. Additionally, a protocol for doctors in official meetings was deemed necessary.

Janardhan further underscored the need to allocate a salary of Rs 52,000 to MBBS doctors serving in rural hospitals. Addressing major concerns related to medical personnel, the representatives advocated for prioritising non-regular medical staff working on contracts in regular recruitments, similar to doctor appointments. They called for the release of pending arrears for second

Auxiliary Nurse Midwives (ANMs) and equal pay for equal work for all medical staff, in accordance with the Supreme Court judgment. Further, job security akin to regular employees was sought for medical staff employed on a contract or outsourcing basis, and compassionate appointments were requested for the families of retired contract/outsourcing staff.

The Association members also urged the implementation of an employee health scheme for all contract/outsourcing staff, mirroring the benefits provided to regular employees.

It was attended by A Vani Prasad, Principal Secretary to Government of Telangana & Director General, EPTRI and Dr N Satyanarayana, C&DMA, Commissioners, Municipal Commissioners, Environmental Engineers and Sanitary Inspectors.

On this occasion, Arvind Kumar said the State government has taken several initiatives in the area of solid waste management including

plastic waste and also added that Faecal Sludge Treatment Plants (FSTPs) were being installed in all the ULBs.

Vani Prasad said the resource efficiency and circular economy were the need of the hour and further stated that EPTRI has established a Waste Recycling Complex (WRC) and will help the municipalities in establishing similar centres for ensuring zero waste concepts.



Sudden rains lash parts of Hyd

THE weather in the city suddenly changed with several parts witnessed downpour on Sunday. The residents, who were reeling under scorching sun till noon, were relieved by the cool weather.

Heavy rain, accompanied by gusty winds lashed several places in Hyderabad like Jubilee Hills, Banjara Hills, Punjagutta, Ameerpet, SR Nagar, Kukatpally, Khairatabad, Abids, Kothi and Dilukhna. The trough is continuing from Vidarbha over Telangana and north Tamil Nadu. Under the influence of the trough, there is a possibility of moderate rains in Telangana for the next three days, the Meteorological department said. Some districts in the State also received rain accompanied by thunderstorms and gusty winds today. On Saturday, the maximum temperature in the State crossed 46 degrees Celsius. Lakkarvaram in Suryapet district recorded the highest maximum temperature of 46.1 degrees Celsius. The meteorological department warned that temperatures would rise further in the next two days.

Moreover, the average maximum temperature is likely to be between 41 and 44 degrees Celsius throughout the first week of June across the State. The weather department officials said strong winds were blowing at low altitudes from the western directions.

Gig workers union demands social security

WITH various incidents being faced by the Gig workers in the city, the Telangana Gig and Platform Workers Union (TGPWU) urged the State government to provide gig workers social security benefits like life insurance, personal accident insurance, and health insurance.

Following the recent incident in Panchvati Colony in Manikonda when an Amazon delivery man, 31-year-old Mohammad Ilyas was forced to jump from the 3rd floor, after a dog attacked him when he went to deliver a parcel. The delivery man received several injuries and the treatment for his injuries costs around Rs 3.7 lakh. Following this, the Telangana Gig and Platform Workers

Union demanded that the dog owner to bear the expenses of the treatment. TGPWU president, Shaik Salauddin said that several such incidents were reported in recent months when dogs attacked delivery persons, but neither the had the owner helped the workers nor the government. "How can a delivery man bear such a huge amount for his treatment?" he asked. Gig workers have been

rapidly increasing in the city, but there is no social security and other provision for gig workers of these firms. Hence, they have been requesting the government and companies to provide social security and other benefits to these workers," he said and added that the platform lacks government laws. These platforms were initiated in 2012 and since then there were no laws, social security and no demands of

the workers were fulfilled. "With various incidents reported in the city, no worker is benefitted with any social security. Though the MAUD Minister K T Rama Rao earlier this month ensured to protect the livelihoods of gig workers, nothing has been done so far," added Salauddin. The TGPWU urged the dog owners to tie their pets when the delivery agents come to deliver and urged

the GHMC Mayor and GHMC commissioner to mandate notice boards regarding pets and must take action if any dog attack incident occurs.

Salauddin said, "Residents' Welfare Associations (RWA) across the city should discuss the matter in their meetings and take appropriate steps regarding the dog attack cases." The union demanded that Amazon should bear Mohammed Ilyas loss of pay as he was injured during duty hours and would not be able to return to work immediately. "His livelihood will be affected by this. So, Amazon should pay him at least Rs 1,000 per day. Taking this incident, Amazon should make a policy for such an incident."
