Secretarial Compliance Report of Share India Securities Limited for the financial year ended March 31, 2025

We have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by Share India Securities Limited (CIN: L67120GJ1994PLC115132) (hereinafter referred as "the Company"), having its Registered Office at 615 and 616, 6th Floor, X-Change Plaza, Dalal Street Commercial Co-operative Society Limited, Road 5E, Block-53, Zone 5, Gift City, Gandhinagar, Gujarat-382050. 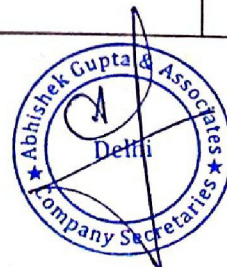

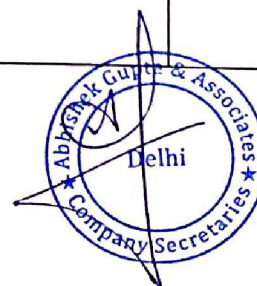
