साल 2020-21 में आई कोरोना लहर में हरियाणा में 10 लाख से ज्यादा मरीज मिले थे, जिनमें से 10 हजार से ज्यादा लोगों की मौत हो गई थी। सबसे ज्यादा मौतें हिमाचल और गुजरात में ही हुई थी। हिमाचल में मौतों का आंकड़ा 1189 और गुजरात में 1037 था। तीसरे नंबर पर पानीपत में 679 और भिवानी में 668 लोगों की मौत कोरोना संक्रमण के कारण हुई थी। हरियाणा में मंगलवार की रात तक कोरोना के 16 केस सामने आ चुके हैं। जिसके बाद स्वास्थ्य विभाग
