Please find enclosed herewith the disclosure under Regulation 29(2) of SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, as received from M/s MVA Finance Private Limited (Transferor Company – 1 and Promoter Group Entity) with regard to transfer (disposal) of 1,44,450 equity shares (0.16%) of **Pasupati Acrylon Limited** to M/s Arihant Exports Private Limited (Transferee Company).
