**REPLY BY SIMBHAOLI SUGARS LIMITED (COMPANY)**

This is with reference to the query received from BSE for stating reason for delay with reference to corporate announcement made by the Simbhaoli Sugars Limited (Company) on January 29, 2026. The 8 MW turbine was repaired and became operational on January 24, 2026. However, the announcement regarding restoration of operations was made with a delay due to certain unavoidable operational and technical considerations.

It is pertinent to note that after repair, the turbine initially operates at a **partial load of approximately 1.2 MW** Additionally, the sugar manufacturing process involves a crystallization cycle of around 72 hours and by this time the complete cycle from cane crushing to sugar production completes and we can achieve the maximum plant load needed for the process, and therefore, operational outcomes can be accurately assessed only after completion of this cycle.

During this period, **the turbine was kept under strict observation, continuous monitoring, and performance testing** to ensure smooth functioning and to avoid any recurrence of breakdown. After satisfactory performance and confirmation of stable operations, the engineer confirmed on January 28, 2026 that the turbine was functioning properly at its intended capacity.
