**Sub: Update on Disclosure pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”)**

Dear Sir/ Ma'am,

In continuation to our earlier intimations dated May 08, 2025 and December 30, 2025 given under Regulation 30 read with Para B (8) of Part A of Schedule III of SEBI Listing Regulations and Para 8 of Industry Standards Note on Regulation 30 of SEBI Listing Regulations, it is to inform that the State Tax Officer, Mandaveli Assessment Circle, Chennai, Tamil Nadu, ('STO, Chennai') has vide its multiple orders dated January 29 & 30, 2026 dropped the tax demand(s) of Rs. 299.24 Crores (along with interest & penalty) pertaining to Financial Years 2020-21 to 2023-24. The aforesaid tax demands were raised through Show Cause Notice by STO, Chennai, which were contested by the Company on the grounds of wrong classification of agricultural tractors as road tractors and wrong computation of the alleged taxes on the total GST turnover instead of only turnover of tractor.

The requisite disclosure pursuant to SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, is enclosed as **Annexure I** for Para B (8) of Schedule III of SEBI Listing Regulations.

The date and time of occurrence of the event (receipt of the first Order from STO, Chennai) is January 29, 2026 at 06:34 P.M. (IST).
