**Subject: Report on Transfer Requests of Physical Shares re-lodged under the special window**

Dear Sir / Madam,

In accordance with SEBI Circular No. SEBI/HO/MIRSD/MIRSD-PoD/P/CIR/2025/97 dated July 02, 2025 (“**SEBI Circular**”), please find enclosed herewith a letter received from the Company’s Registrar and Transfer Agent viz. Beetal Financial and Computer Services Private Limited, regarding transfer requests for physical shares that were re-lodged for transfer cum demat during the period commencing from December 01, 2025 to December 31, 2025, under the special window provided by the SEBI.

Further, as mentioned in the RTA’s certificate, during the month of December, 2025, Six (6) requests have been received for transfer of shares in physical mode under the special window. In these cases, due to mismatch/non-availability of transferor’s signature and non-availability of requisite documents of transferors, the Company has issued a public notice by way of a press advertisement dated January 1, 2026, granting a period of thirty (30) days for raising objections, if any, in accordance with SEBI Circular No. SEBI/HO/MIRSD/DOS3/CIR/P/2018/139 dated November 6, 2018. The said objection period shall conclude on January 31, 2026. Accordingly, these Six (6) transfer requests are presently under process.

However, in the format of report specified under the abovementioned SEBI Circular, which is required to be submitted by the Company to the Stock Exchange on monthly basis, specifying the detail of transfer request received under special window, there is no option of “pending request” category. Therefore, the RTA has reported that Six (6) requests have been approved.

Further, in terms of SEBI Circular No. SEBI/HO/MIRSD/DOS3/CIR/P/2018/139 dated November 06, 2018, the Company shall approve the aforesaid transfer requests upon completion of the objection period on January 31, 2026, provided no objections are received within the stipulated time.
