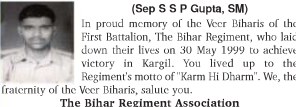

By the late 1980s, militancy in Punjab was escalating, with terrorists gaining strength through access to sophisticated weaponry. To counter their growing influence, the CRPF was deployed in large numbers, including 38 Battalion, which was stationed in the district of Tarn Taran. On 30 May 1989, a CRPF team was tasked with area domination and patrolling in Mehmoondar village, Tarn Taran. During the operation, they were ambushed by terrorists, triggering a fierce exchange of fire that lasted several hours. Despite the element of surprise and the enemy's superior firepower, the jawans fought back valiantly, forcing the attackers to retreat. In this intense encounter, six brave hearts—LNk Bishan Singh, Nk Inra Bahadur Subba, L/Nk Bachhan Singh, Constable Divaker Swain, Constable Ram Gopal Yadav, and Constable Din Mohammad—made the supreme sacrifice in the line of duty.

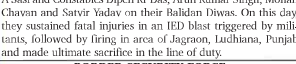

On 30 May 2008, troops of 2 Battalion of CRPF were conducting an area domination patrol to prevent Maoist sabotage in Majhar Parakei Kalyan market, PS Katakalyan, district Dantewada. The market was crowded and bustling with activity. Amid the crowd, a Maoist supporter Constable G. Ranganathan from behind, pulled out a concealed pistol, and opened fire. Though injured, Constable Ranganathan attempted to retaliate, but the assailant disappeared into the crowd. Exerting remarkable restraint to avoid civilian casualties, the troops held their fire. Constable G. Ranganathan was evacuated but succumbed to his injuries during treatment. His sacrifice remains a profound loss to the nation.

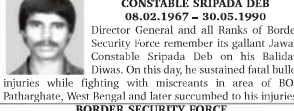

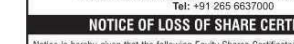
