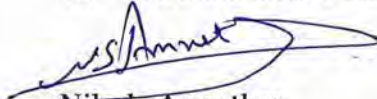

Report on the Audit of Consolidated Financial Results

Opinion

We have audited the accompanying Consolidated annual Financial Results of **UNITED INTERACTIVE LIMITED** (hereinafter referred to as the 'Holding Company') and its subsidiaries (The Holding Company & its subsidiaries together referred to as "the Group") for the year ended 31st March 2025, ('the Statement') attached herewith, being submitted by the Holding Company pursuant to the requirement of Regulation 33 of the Securities and Exchange Board of India (SEBI) (Listing Obligations and Disclosure Requirements) Regulations, 2015, including relevant circular issued, as amended time to time ('Listing Regulations').

In our opinion and to the best of our information and according to the explanations given to us and based on the consideration of report of on separate audited financial statements, financial information of the subsidiary, the aforesaid Consolidated Financial Results:

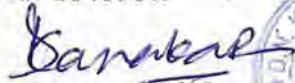
