With reference to the provision of Regulation 30 read with Part A of Schedule III of SEBI Listing Regulations, this is to inform you that BSE Ltd. vide their e-mail dated June 27, 2025, has imposed a penalty of Rs.1,53,400/- (Rupees One Lakh Fifty Three Thousand Four Hundred only) (inclusive of GST) for alleged Non-compliance of Regulation 23(9) i.e., disclosure of related party transactions on consolidated basis.

	<p>In this regard we would like to clarify that in accordance with the fourth proviso to Regulation 23(9) of the SEBI (LODR) Regulations, 2015, as inserted by the SEBI (LODR) (Third Amendment) Regulations, 2024 effective from December 13, 2024, <i>remuneration and sitting fees paid by the listed entity or its subsidiary to its director, key managerial personnel or senior management, except who is part of promoter or promoter group, shall not require disclosure under this sub-regulation, provided that the same is not material in terms of the provisions of sub-regulation (1) of this regulation.</i></p> <p>Except the remuneration paid to the KMPs there were no related party transactions undertaken by the Company during the reporting period. As these payments were not material in terms of the provisions of Regulation 23(1), they do not fall within the scope of disclosure as per the above-mentioned provisions. Therefore, there is no violation on the part of the Company in respect of disclosure of related party transactions. This matter has already been clarified to the Exchange in response to a separate query.</p>

Further the matter is being taken up before BSE for revocation of the penalty in view of the foregoing. Any further development in this regard shall be updated.</p>
