**Sub: Rohtak-Hissar Tollway Private Limited (a wholly owned subsidiary of the Company or SPV or RHTPL) has submitted Notice of Termination of project with National Highways Authority of India (NHAI) as per Concession Agreement.**

With reference to above subject and pursuant to the Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, read together with the circulars and notifications issued thereunder ("Listing Regulations"), we would like to inform you that Rohtak-Hissar Tollway Private Limited (a wholly owned subsidiary of the Company or SPV or RHTPL) vide its letter dated 27<sup>th</sup> August, 2021 has submitted Notice of Termination of project as per Concession Agreement dated 27<sup>th</sup> May, 2013 with National Highways Authority of India (NHAI) on 28<sup>th</sup> August, 2021 due to forceful suspension of toll collection/ User Fee because of the farmers' agitation / protest with effect from December 25, 2020.

Also note that the event of forceful suspension of toll collection/ User Fee because of the farmers' agitation / protest with effect from December 25, 2020, amounted to a Force Majeure Event as per the provisions of the Concession Agreement with NHAI.

d	Details of amendment or reasons for terminations and impact thereof (to the extent possible);	<p><b>Details of amendment or reasons for terminations:</b> RHTPL vide its letter dated 27<sup>th</sup> August, 2021 has submitted Notice of Termination of project as per Concession Agreement dated 27<sup>th</sup> May, 2013 with NHAI on 28<sup>th</sup> August, 2021 due to forceful suspension of toll collection/ User Fee owing to the farmers' agitation / protest with effect from December 25, 2020, amounts to a Force Majeure Event as per the Provisions of the Concession Agreement with NHAI.</p> <p><b>Impact thereof (to the extent possible):</b> As the final termination is initiated by the Concessioner, the impact is likely to be in favour of the lenders as well as the company as the toll collection was at standstill for more than six months. NHAI in line with terms and conditions of Concession Agreement being met, will take over the project.</p>

*National Highway Authority of India ("NHAI") awarded the work of "Four Laning of Rohtak to Hissar Section of NH 10 from Km. 87.000 to Km. 170.000 including connecting link from Km. 87.000 (NH 10) to Km. 348.000 (NH 71) in the State of Haryana on DBFOT (Toll) basis" ("Project") to M/s. Rohtak Hissar Tollway Private Limited ("RHTPL"/"Concessionaire") vide Concession Agreement Dated May 27, 2013 ("Concession Agreement").*


*RHTPL had received appointed date on 26th December, 2013 for the Project. Original concession period is 22 years from the appointed date. RHTPL had received Provisional Completion Certificate for 100% length of 98.81 km on 30th July, 2016 and accordingly toll collection has been started on the Project from 3<sup>rd</sup> August, 2016.*

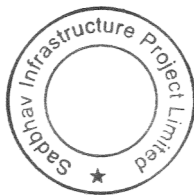
