Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that the Company has issued a clarification regarding an inadvertent typographical error in the Explanatory Statement pursuant pertaining to the preferential allotment, as mentioned in the Notice of the Extraordinary General Meeting dated November 13, 2025.

In the said Explanatory Statement under Item No. 2, the following was inadvertently stated and is now being corrected through this intimation, as mentioned below;

1. For Item No.2- part of para 1, page no. 10 of the Notice be modified and read as follows:
