With reference to the captioned subject, we would like to inform you that the company M/s. Fusion Foods and Catering Private Limited, a Subsidiary of Updater Services Limited ('Holding Company'), has received an order from the office of the Assistant Commissioner, Chennai, Tamil Nadu for an amount of Rs. 1,01,42,848/- under Sec 73 of the CGST Act, 2017.

Based on the company, M/s. Fusion Foods and Catering Private Limited's assessment, the order has been passed without considering the response which we have submitted against the notice. The holding company is in the process of exploring all legal options including filing writ / appeal before the Appellant authority and the company Updater Services Limited is hopeful that there will be no significant financial impact in this case.
