Pursuant to Regulation 30 read with Para A of Part A of Schedule III of SEBI Listing Regulations, we hereby inform you that, the Company has received an Order dated December 29, 2025 from the Office of The Assistant Commissioner of Central Tax, Division-II (Pimpri), CGST, Pune-I, Commissionerate, GST Bhawan, Akurdi, Pune 411 044, demanding tax of INR 35,29,594 plus interest as applicable and penalty of INR 35,29,594 under the Central Goods and Services Tax Act, 2017. The demand pertains to alleged non-payment of GST liability under the Reverse Charge Mechanism (RCM).

The Company is in process of filing an appeal against the said Order. There is no material impact on the financials, operations or other activities of the Company due to this penalty.

The information as required under Clause 20 of Para A of Part A of Schedule III of the SEBI Listing Regulations is enclosed in the **Annexure**.
