**Sub: Update on Disclosure pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”)**

Dear Sir/ Ma'am,

This has reference to our earlier intimation dated May 08, 2025 given under Regulation 30 read with Para B (8) of Part A of Schedule III of SEBI Listing Regulations and Para 8 of Industry Standards Note on Regulation 30 of SEBI Listing Regulations issued by SEBI vide its circular dated February 25, 2025, whereby we had informed that the State Tax Officer of GST, Chennai, Tamil Nadu had issued Show Cause Notices ('SCN') proposing tax demands along with interest and penalty, for the Financial Years 2018-19 to 2023-24, against which, the Company contended that it was anticipating no material financial impact since the GST department had wrongly classified agricultural tractors as road tractors and wrongly computed the alleged taxes on the total GST turnover instead of only turnover of tractors.

In continuation to the above, it is now informed that the Company contested the aforesaid allegation(s) of GST Department by filing written objection(s) and in effect of the same, the State Tax Officer, Mandaveli Assessment Circle, Chennai, Tamil Nadu has passed order dropping tax demand of Rs. 43,25,58,315/- along with interest & penalty, for the Financial Year 2018-19.

The requisite disclosure pursuant to SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, is enclosed as **Annexure I** for Para B (8) of Schedule III of SEBI Listing Regulations.
