Analysis of the Financial Results

About ABM Knowledgeware Ltd:

ABM Knowledgeware Limited (BSE: 531161), operates in three high tech verticals i.e. E-governance, Cybersecurity and Agritech. The Company announced its financial results for the Quarter and Nine Months Ended December 31, 2025.

Summary of Key Financial Parameters

On a Consolidated basis across Digital Governance, Cybersecurity and Agritech, ABM reported operational revenue of ₹30 crores for Q3 FY 2025–26. The Company posted consolidated EBITDA, PBT and PAT of ₹6.7 crores, ₹5.6 crores and ₹2 crores respectively. Despite ongoing efforts to right size operations and develop new competencies, ABM achieved approximately 25% Gross Profit Margin and 13% Operating Profit Margin. As per ongoing guidance, the Company is undergoing a medium term strategy of right sizing some of its operations in favour of initiatives in the space of Agritech and Cybersecurity with medium term and ongoing impact on profitability.

Segment Highlights

Digital Governance

Standalone revenue for Q3 FY 2025–26 increased to ₹25.70 crores from ₹20.40 crores in the corresponding quarter of the previous year, representing a 20% year-on-year growth.

During the quarter, the segment maintained a Gross Profit Margin of 16% and a Net Profit Margin of 9%, reflecting impact of the right sizing some of the operations.

Cybersecurity

InstaSafe Technologies Private Limited, ABM's cloud-based cybersecurity subsidiary, reported Q3 revenue of ₹5.03 crores and profit of ₹1.53 crores, compared with revenue of ₹6.73 crores and profit of ₹3.28 crores in the corresponding quarter of the previous year.

The year-on-year decline in revenue and profitability was primarily attributable to lower billing from one of the Company's key customers, while operations with other customers remained stable. InstaSafe added five new customers in the space of AI, Finance and Technology.

Agritech

Scanit Global :

Secured first year-round indoor air-quality monitoring contract with strong multi-facility expansion potential in the USA. Scanit was shortlisted for strategic discussions with US Administration for Preparedness on airborne pathogen detection technologies in possibility of airborne pathogens being weaponized against humans. In Canada, a multi-state full service ag-retailer signed pilot for wheat and canola; In Europe existing large tractor manufacturer renewed interest for 3rd-year vineyard trial. There has been continued interest in the Scanit technologies seen in renewals and addition of pilots in newer geographies and newer customer segments.

Scanit India:

In a major milestone Scanit's Technology is tested and certified by two Maharashtra agricultural universities under Government-funded Hackathon. While Scanit has several global validations, such Indian credible certifications will help in easier access to govt organisations. An MoU is signed with Indian Institute of Vegetable Research (Under Indian Council of Agri Research, GoI) for adding to the capability of detecting more pathogens to meet the rising demand.

After successful commercial pilot last year, one of leading Agritech company in private sector has implemented India's first Autonomous Airborne Disease Surveillance Network covering 10X more acres (1000+ acres) and hundreds of farmers in Nashik and Sangli.

For enhancing the product and technology AI is integrated deeper into SporeCam training workflow; analytics is upgraded to provide *hourly* risk alerts, enhancing competitive positioning.

India-based global lead-gen team is improving quotation conversion efficiency.

From the view point of challenges faced, it is seen that the scaling is slower than targeted due to multiple seasons pilots undertaken by the customers.

Other Significant Developments:

1. Ambitious Reform Project of UP Govt for Simplified Building Plan Approval (UP FAST PASS) Goes Live-Phase-wise.

FASTPAS (Fast & Simplified Trust-Based Plan Approval System) achieved the soft launch of key functionalities. This is a milestone in the reforms undertaken by UP Govt for an Ease of Online Building Plan Approval.
