Subject: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended

Further to our disclosure bearing Ref No: SSLL/42/2024-2025 and Ref No: SSLL/43/2024-2025 both dated 12th August 2024 and Ref No: SSLL/70/2024-2025 dated 14th November 2024 and pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Para A of Part A of Schedule III and read with the SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023 and further to our update submitted to the exchanges on 5th January 2024 regarding fire reported on one of our vessel, M.V. SSL Brahmaputra (referred as the "Vessel"), wherein three claims lodged against the Company by the Claimants on account of fire incident onboard of the Vessel on 01st January 2024, the details of Case 1, Case 2 and Case 3 in this regard has been disclosed and filed with the Stock Exchanges (NSE and BSE) vide Ref No: SSLL/42/2024-2025 and Ref No: SSLL/43/2024-2025 both dated 12th August 2024 and Case 4 and Case 5 has been disclosed and filed with the Stock Exchanges (NSE and BSE) vide Ref No: SSLL/70/2024-2025 dated 14th November 2024 and Case 6 has been disclosed and filed with the Stock Exchanges (NSE and BSE) vide Ref No: SSLL/71/2024-2025 dated 02nd December 2024. Kindly note that the aforesaid cases are currently pending for adjudication before the respective Hon'ble Courts.

Subsequent to the above, the Hon'ble High Court of Judicature of Gujarat at Ahmedabad, by order dated 30 January 2026, issued a Warrant of Arrest against the Vessel SSL Brahmaputra (IMO No. 9238806), presently lying at Kandla Port, pursuant to the alleged claim made by the 3 Cargo Claimants i.e., Topulent Agro Producer Limited, Ms. Archana Laxman Pawar, and Ms. Kiran Navanath Doke ("Plaintiffs") against the said Vessel. The said suits arise out of the same fire incident onboard the Vessel on 01 January 2024 during the relevant charter and seek damages allegedly arising from spoilage of grape consignments transported in containers.

Accordingly, the Hon'ble High Court of Gujarat passed a formal order of arrest against the said Vessel. However, since we duly submitted letter of undertaking to furnish security within 6 weeks on without prejudice basis against the alleged claim amount of Rs. 16,91,696 (Topulent Agro Producer Limited), Rs. 16,91,696 (Ms. Archana Laxman Pawar), Rs. 18,28,334.40 (Ms. Kiran Navanath Doke). The Hon'ble High Court was kind enough to pass a release order and recorded the same simultaneously in the said order dated 30 January 2026 (i.e., arrest order cum release order)"

The Vessel is accordingly now permitted to sail from the Port of Kandla.
