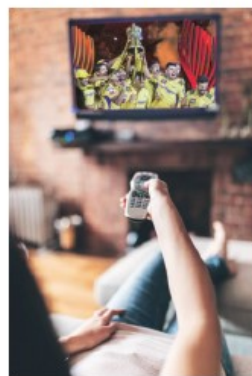
What India splurged on during IPL 2023

Biryani remains the most-ordered dish on delivery platform Swiggy, during the cricketing extravaganza, which came to a close in the wee hours of Tuesday

I thought pizza was on top of the mind of most Indians glued to the television set while watching their daily dose of Twenty20 cricket, the Indian Premier League (IPL) season, you could not be more wrong. It was biryani that was once again the "most ordered dish" on Swiggy, shows data released by the food aggregator, which serviced a staggering 12 million biryani orders. That's 212 orders per minute for the famous rice dish alone. That fact isn't

all. After Ravindra Jadeja's fireworks brought down curtains on the two-month extravaganza, leading Chennai Super Kings to its record-equalising fifth title, food aggregator platform Swiggy shared what the country ate as they watched the matches. While some of the data point to some unique trends so far as ordering during the games concerned, some others were record-breaking.
