The **(01/2025-26) Extra Ordinary General Meeting** of the Equity Shareholders of Arihant Capital Markets Limited (CIN: L66120MP1992PLC007182) held on Thursday, July 31, 2025, at 12:30 P.M. IST through Video Conferencing / Other Audio-Visual Means.

Dear Sir,

1. I, Virendra G. Bhatt, Practicing Company Secretary, have been appointed as Scrutinizer by the Board of Directors of Arihant Capital Markets Limited ("**the Company**") for the purpose of scrutinizing the process of voting through electronic means ("**e-voting**") on the resolutions contained in the Notice dated 08th July, 2025 ("**Notice**") issued in accordance with the Circulars issued by the Ministry of Corporate Affairs ("**MCA**"), Government of India (hereinafter referred to as "**MCA Circulars**") and the Securities and Exchange Board of India (hereinafter referred to as "**SEBI Circulars**"), calling the Extra Ordinary General Meeting of the Equity Shareholders ("**the Meeting**" / "**EGM**") through Video Conferencing / Other Audio-Visual Means. The EGM was convened on Thursday,



July 31, 2025, at 12:30 P.M. IST through Video Conferencing / Other Audio-Visual Means.

2. The said appointment as Scrutinizer has been in accordance with the provisions of Section 108 of the Companies Act, 2013 ("**the Act**") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended ("**the Rules**") and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirement) Regulations, 2015 ("**LODR**"). As the Scrutinizer, I had to scrutinize:
 - (i) process of e-voting remotely, before the EGM, using an electronic voting system the dates referred to in the Notice calling the EGM ("remote e-voting"); and
 - (ii) process of e-voting at the EGM through electronic voting system.

1. Management's Responsibility

The management of the Company is responsible to ensure compliance with the requirements of (i) the Act and the Rules made thereunder; (ii) the Circulars; and (iii) the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, ("LODR") relating to e-voting on the resolutions contained in the Notice. The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems.

2. Scrutinizer's Responsibility

My responsibility as a scrutinizer for e-voting process is restricted to making a Scrutinizer's report of the votes cast "in favour" or "against" by the members in respect of the resolutions contained in the Notice. My report is based on verification of data and reports generated from the e-voting system provided by National Securities Depository Limited ("**NSDL**"), the Agency authorized under the Rules and engaged by the Company to provide e-voting facility and attendant papers / documents furnished to me electronically till the time fixed for closing of the e-voting process i.e. till 05:00 p.m. on Wednesday, 30th July, 2025.

3. Cut-off date

The Members of the Company as on the "cut-off" date as set out in the Notice i.e. Thursday, July 24, 2025 were entitled to *vote* on the resolutions set out in the Notice and their voting rights were in proportion to their shareholding in the



paid-up equity share capital of the Company as on the cut-off date, subject to the provisions of Articles of Association of the Company.

4. Remote e-voting process

- i. The remote e-voting period remained open from Monday, July 28, 2025, at 09:00 A.M. and ends on Wednesday, July 30, 2025, at 05:00 P.M.
- ii. The votes cast during the remote e-voting were unblocked on Thursday, 31st July, 2025 after the conclusion of e-voting period for EGM and was witnessed by two witnesses, Ms. Niyati Patel and Ms. Sneha Agarwal who are not in the employment of the Company and / or NSDL. They have signed below in confirmation of the same.
