Dear Sir/Ma'am,

Pursuant to Regulation 30 of the Listing Regulations read with Part-B of Schedule III of Listing Regulations and SEBI Circular SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, We are hereby informing that due to **breakdown of 8MW turbine of Power Unit** at Brijnathpur, U.P on 30<sup>th</sup> December, 2025. The Operations are temporarily disrupted at the said unit, the exact period of closure cannot be ascertained.

Adequate steps are being undertaken to restore the operation of the plant. The Company is in the process of ascertaining the cause of the issue and the actual loss caused by it.

There is adequate insurance coverage for said plant and intimation to Insurance Company is made.

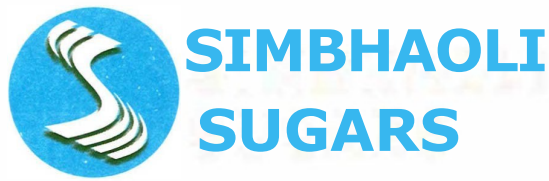
