Sub: Update on Disclosure made on November 26, 2024 pursuant to Regulation 30 read with Schedule III of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 for Acquisition of Balance Stake by Aster DM Healthcare Limited (the "Company") in Prerana Hospital Limited.

This is in furtherance to our earlier disclosure dated November 26, 2024, wherein the Company had informed about entering into a share purchase agreement for acquiring additional equity shares representing 13% (Thirteen percent) of the paid-up share capital of Prerana Hospitals Limited (increasing the Company's shareholding from 87% to 100%).

We hereby inform you that the Company, on December 30, 2025, acquired additional equity shares representing 11.94% (Eleven point nine four percent) of the paid-up share capital of Prerana Hospitals Limited, thereby increasing the Company's shareholding from 87% to 98.92% with balance 1.08% to be acquired by 31<sup>st</sup> December 2026.

The relevant details as required under Regulation 30 of the SEBI Listing Regulations read with SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, are provided as Annexure I.

The Company will make appropriate disclosures to the Stock Exchanges as and when there is any material development in this regard.
