With reference to the captioned subject, we would like to inform you that the Company has received an Order from the State Tax Officer, GST, Ranchi - South, Jharkhand imposing a penalty of Rs. 2,04,425.35/- with respect to GST assessment for the FY 2021-2022 under applicable provisions of the Jharkhand GST Act 2017, CGST Act 2017 and IGST Act 2017 in relation to alleged excess Input Tax Credit claimed by the Company for the said period.

Based on the Company's assessment, prevailing law and basis the advice of the counsel, the Company is hopeful of a favourable outcome at the next adjudicating authority/ tribunal level and does not reasonably expect the said Order to have any material financial impact on the Company.
